Purpose: To document and implement programs for the maintenance of all Protection Systems, Automatic Reclosing, and Sudden Pressure Relaying affecting the reliability of the Bulk Electric System (BES) so that they are kept in working order. 1 when the substation is less than 10 circuit-miles from the generating plant or the largest generating unit within the Reserve Sharing Group, as applicable, is subject to change. 118 synchrophasors, and is ideal for directional overcurrent applications. 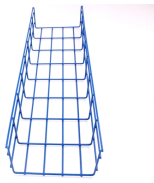
