Overview

Many utilities require a formal request submission, often through an online portal or a specific form, which must detail the reason for the move and propose a new location. The utility will then perform an initial assessment and a site visit with a technician or planner. Relocating a utility box on your property is a manageable task, but it involves a formal process with the responsible utility company. 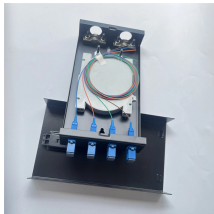

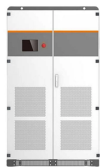
